#### Treasurer's Report to AGM for the Year Ended 31st March 2021.

## **Annual Report to AGM.**

This year has been dominated by the COVID-19 pandemic and the Friends, like other charities, have been unable to hold any fundraising events or activities which has severely impacted our income and our ability to support any projects.

Our only significant income has been from standing orders. Regrettably, during the year three of our valued supporters stopped their standing orders reducing our income from that source. We thank them for their generous support in previous years.

The Gift Aid claim for 2018-19 was delayed by a clerical error on the part of HMRC and so was not received until this financial year. As a result, we received 2 repayments including the refund from 2019-20.

In July, we registered for the Amazon Smile scheme and a small amount was earned from supporters who kindly nominated the Friends to receive payments earned by their purchases. The payment earned is 0.5% of the purchase value, paid periodically when a minimum amount has accumulated.

Due to the wider effects of COVID-19, bank interest rates have been extraordinarily low, the Bank of England official rate finishing at 0.1%. This is reflected in the amount earned. CCLA, who manage our deposit fund, have given notice of the possibility that interest may drop even further raising the potential of a negative rate.

Income breakdown for the year is as follows:

- Income from standing orders totalled £950, down from £1,130 last year.
- Gift Aid claims for 2018-19 and 2019-20 totalled £489.
- The Amazon Smile scheme produced in income of £11.
- The deposit fund account earned £10 interest.

Such grants as the Friends have made have been funded largely from our accumulated reserves which has resulted in a much reduced end-of-year balance of £4,284.

We have made grants to the PCC Fabric Fund during the year for some major works totalling £8,845 made up as follows:

- The tower survey to assess movement from subsidence came to £745.
- Part contribution to the fees to date for architects to investigate the causes of the north aisle subsidence including examination of the drainage system came to £3,778.

• Part contribution to the costs of replacing dry rot affected flooring around the centre aisle, installing under-pew heating and to making the pews removable to enable more flexible use of the space came to £4,322.

The cost of running the web site was £98.

There were no other administration costs.

The end-of-year summary for 2020-2021 is shown in the table below showing, as expected, a significant excess of expenditure over income.

The final table shows the summary of funds raised and distributed since the formation of the Friends in 2004 showing that the total sum we have raised has passed the six figure milestone at £100,117. More importantly, the total amount we have given in grants has now reached £95,833, a tremendous achievement.
