

Treasurer's Annual Report for the Year Ended 31st March 2022.

The early part of the year was lost to the continuing effects of the Covid-19 pandemic during which time there were no fundraising activities with our only significant income being from standing orders.

For some time, it had proved difficult to find volunteers to help with Friends events and to fill officer positions. Several of the existing officers had declared that they wished to stand down and as a result a Special General Meeting to discuss the future viability of the Friends was called for September. Happily, there was a good turnout of interested parties willing to step in to continue the valuable work of the Friends. With new enthusiasm and the gradual lifting of COVID restrictions, the Friends set about restarting fundraising activities. Several ideas for fundraising have since been proposed although most of these are unlikely to yield funds until next financial year.

With the gradual exit from the COVID pandemic, interest rates have crept back from the brink, finishing the year at 0.75% having been as low as 0.1%. This has resulted in a small increase in interest earned on the COIF deposit account. The effects of the war in Ukraine are dramatic and far-reaching and are likely to adversely affect our fundraising efforts for the coming year.

In this year, we participated in the East Anglian Daily Times 'Cash4Charities' promotion which earned us a donation of ± 158 . Our thanks are due to all those who diligently collected the vouchers.

Income from standing orders totalled \pm 940. This continues to be the bedrock of our fundraising.

The Company of Friends, the collaboration between us and the Friends of St Georges which staged three highly successful pantomimes, was wound up during the year having been dormant for some years. Working funds left in the account were divided equally, our share being \pounds 72.

The Bacton Farewell Fireworks Display gave us a donation of £200.

Our Gift Aid claim for 2021-22 yielded £167, all from donors who generously give by standing order.

The Amazon Smile scheme produced an income of £35.

The deposit account earned £1 interest.

The Friends have made just one grant to the PCC Fabric Fund during the year, for the installation of under-pew heaters, of $\pounds 1,000$. To enable full use to be made of these heaters, the power supply to the church needs to be upgraded but this work has yet to be scheduled. The cost will be significant and the Friends are likely to be asked to contribute when the time comes.

The cost of running the web site was £103.

There were no other administration costs.

The end-of-year summary for 2021-2022 is shown in the table below which reflects the low level of activity in both fundraising and grants. The financial year ended with a net income of \pounds 228 and balance in the accounts of \pounds 4,512.

Summary to the end of March 2022

The balance in the accounts stood at **£4,512** of which £4,403 is in bank accounts and £109 in petty cash.

The income for the year was £1,582 with expenditure of £1,354 leading to a net inflow of **£228.**
