## Treasurer's Annual Report for the Year Ended 31st March 2025.

The Friends continue to support the upkeep of the church with grants funded by income from our fundraising activities.

Standing orders are a consistent source of income and our gratitude goes to these supporters, most of whom have been regular contributors since the Friends were formed in 2004. These donations contributed £842 over the year, boosted by a Gift Aid refund of £181.

The Friends received donations in memory of Frank Johnson and Tony Finbow, both of whom had been long-standing supporters of the Friends, totalling £634.

The D-Day Concert in June was extremely successful, raising £1,339 from ticket sales and from the bar. Also in June, the Village Fête and Draw combined raised £1,787. In December, the Christmas concert given by the Norwich Accordion Band raised £854 bringing the total raised from these events to £3,981.

As a matter of policy, the Friends as a group have decided to focus attention on fewer but larger events such as the Village Fête and concerts since these have historically been the most effective fundraisers by some orders of magnitude.

Bank interest rates remained firmly in the low single digits, yielding us £121 in interest payments.

Public liability insurance cost us £266 for the year, provided by Ecclesiastical Insurance who continue to offer the best value and appropriate cover.

A grant of £4,000 was made in April to the church to help fund the North-West Wall project, in particular the structural report by Fran Adams which was very thorough and made a number of recommendations for remedial action to combat the subsidence.

The website, which also provides dedicated e-mail mailboxes for the officers, cost £170 for the year. The website contains a comprehensive archive of all meeting minutes and Treasurer's reports from the formation of the Friends in 2004. As well as articles and photographs of most of our past events, it now provides an online advertising and e-store platform for the purchase of event tickets and draw tickets. Whilst relatively few have been purchased online to date, the introduction of QR codes into publicity material should boost this sales avenue. There is also the means to make online donations. Membership and standing GDPR, Safeguarding and Privacy documents are available for download. The site additionally provides some historical background to St Mary's Church and the war graves in the churchyard and cemetery.

Total income for the year was £5,920 and expenditure £4,618. We go into the 2025-26 financial year with a healthy balance of £9,321.

Since the Friends were formed in 2004, we have made grants to the church totalling £106,257.

The balance in the accounts stood at £9,321 of which £9,245 is in bank accounts and £76 in petty cash.

The income for the year was £5,920 with expenditure of £4,618 leading to a net inflow of **£1,303**.
