Summary for the year ending March 2010

The balance in the accounts stood at £14,963 at the end of March, of which £4,963 is in the current account and £10,000 in the investment account.

The total income for the year was £7,566 with expenditure of £11,768, leading to a **net outflow of £4,202**. Excluding donations for repair work to the church, the **net income was £6,322**.

These figures have been reported in the Annual Report.

Gift Aid

A Gift Aid reclaim of £332 has been confirmed by HMRC, and will be paid into our bank account shortly (2009 - £471).

Accounts for first two months of 2010/11

The balance in the accounts stands at £14,938 at the end of May, of which £4,938 is in the current account and £10,000 in the investment account.

The movements to date comprise Standing Order income of £108, interest income of £12 and a donation to the PCC for repairs to the lead lean-to roof of £145 (net outflow of £25).

As mentioned above, £332 gift aid has been confirmed but not yet deposited by HMRC.

There will also be a donation of £1500 from The Company of Friends from the proceeds of the successful pantomime.
